#### **DIRECTORS COLUMN**

I had the chance to sit down the other day and read the latest MRF Reports (Motorcycle Riders Foundation, Washington, DC). There were several articles that caught my eye. First was a piece about the motorcycle crash causation study that was mandated by Congress. It seems the man in charge of the study, Dr. Samir Ahmir, PhD, PE, has resigned from his position. He states, "I have serious reservations about the value of the study with the existing Federal Highway Administration's involvement. My expectations of the study are very low."

Next there was a good item about the relationship between helmets and fatalities. The U.S. Census Bureau says there were 7,883,000 registered motorcycles in 2009. The National Highway Traffic and Safety Administration reported 4,462 motorcycle fatalities in that year. While helmet states had 40% of the registrations (3,186,000), they had 42% (1,871) of the fatalities. Freedom states had 60% of registrations, yet only 58% of the fatalities. Whatever the cause, it is more dangerous to ride in a state with a helmet law. That's a fact!

Last was news from California. They have passed a law that Google's robot cars will be allowed on the road. This Intelligent Highway idea scares me more than anything else. You may be able to sit in the back seat of your car and let the computer drive you home, but that's not going to work with a motorcycle. I really wonder if there's

going to be a place for two wheelers on the streets of the future.



#### "TO THE HILL!"



I write this article after the end if a highly successful first week for this org at the TN Legislature. Your work on the campaigns and at the polls has really paid off. Tony and I were warmly and graciously received when we were looking forward to graciously receive them! It was an enormous honor to be there to represent you. Thank you again for your confidence and esteem.

We began the week with a couple of commitments to sponsor our bills. Tony and I shored those commitments up and moved immediately into sponsors for the remaining. This was important since a bill limit was being discussed in special committee.

We were honored to have a meeting with GOP Caucus leadership followed by a meeting with Speaker Harwell on Wednesday. We enjoyed a wealth of advice and encouragement. This truly is a new year in the motorcycle lobby!

So I am happy to report that we have sponsors for bills that the Legislative Committee voted to run.

The committee directed that Tony and I investigate the possibility of a vanity tag that carries our safety message "Dying to be Seen" with an image of a motorcycle with the shape of TN if possible. We have investigated all the requirements and our 501 status is completely within the parameters necessary to establish and manage a trust.

Representative Courtney Rogers is going to jump in to get her feet wet on our vanity tag bill. Senator Charlotte Burks agreed to carry the senate side of our vanity tag bill.

The goal of this bill will be two fold: we will get our message to look for us out in a new venue and opportunity and we can collect revenues to help out motorcyclists involved in an accident caused by an uninsured motorist. Basically it will be a 'downed biker' fund but with specified parameters and a small executive committee to administrate and report to the Dept. of Revenue.

There are some final details still being ironed out on our liberty bill but there are very exciting details to share. So this article might seem a little scant in information and likely by the time you read this you will be able to get an update on the legislative page of our website (cmtabate.com).

The Right of Way Violation (ROWV) task force will be meetings with different oversight departments for law enforcement, prosecutors and judiciary next week. We are meeting to address the issue with non-enforcement of our Right of Way Violation law and Ricky Otts Act.

And most importantly, our Lobby Day has been scheduled for March 19th, I will learn tomorrow about our parking permit so again, the best place to get the most up to the minute information will be by checking the legislative page on our website.

A very happy New Year to all. It is indeed a very exciting year for motorcycle legislation. Thank you for all your efforts to make this such a promising experience!

We can do it WITH ya but we can't do it WITHOUT ya!

Bash – The date will be changed in the newsletter, the correct date is September 13-15, 2013.


Safety and Ed-We decided to continue the bus sign again this year.
